IMPORTANT INSTRUCTIONS TO DEFENDANT

Pursuant to a court order, you must transfer all firearm(s) in your possession and the transfer of firearms must be supervised by the Jefferson Parish Sheriff's Office (JPSO). If you do not possess firearms or transferred all firearms in your possession prior to the issuance of the order to transfer, you must complete a Declaration of Non-Possession of Firearm(s).

FOLLOW THESE INSTRUCTIONS TO TRANSFER FIREARMS:

DO NOT BRING FIREARMS INTO SHERIFF'S OFFICE BUILDINGS.

- 1. Immediately contact JPSO by dialing 911 to initiate the "Proof of Transfer" process. Inform the call taker that the court has ordered you to transfer your firearm(s) and that you are requesting a deputy to oversee the transfer. You must disclose the following:
 - a. Full name and date of birth
 - b. The method of transfer you wish to utilize

 - c. The number and brief description or guns to be transferred.
 d. Your contact information, so that you may be reached by the responding deputy
 - e. The location in which you request the transfer to take place
- 2. When you contact the JPSO to schedule your transfer you must be prepared to choose from the following transfer options:
 - a. Allow the Sheriff's Office to oversee a third party transfer of firearms.
 - b. Allow the Sheriff's Office to oversee the legal sale of the transferred firearms to a third party through a licensed firearms dealer.
 - The Sheriff's Office may store the transferred firearms for a fee that must be paid prior to C. the firearms being returned.
 - i. Fee of \$200 for 1-10 guns
 - ii. Fee of \$100 for each group of 10 guns beyond the first 10 guns

Based on the method of transfer chosen, the call taker or responding deputy will provide you with additional information.

A fee will be assessed by the JPSO to store any firearms, oversee the legal sale of the transferred firearms, or to transfer firearms to a contracted storage facility. Transferred firearms may be held until all outstanding fees are collected.

If a third party transfer option is chosen pursuant to state law, a Third Party Transfer of Firearm(s) Acknowledgement form must be completed and provided to JPSO at the time of transfer. This form notifies the third party of the relevant state and federal laws and consequences for noncompliance.

For the safety of the deputy and all those involved in any transfer, the following must occur:

- a. All firearms shall be unloaded prior to the deputy's arrival.
- b. The transferor or any third party shall not be in possession of any firearm when the deputy arrives on scene.
- c. The transferor or any third party shall not attempt to handle any firearm while the deputy is on scene.
- d. The transferor or any third party shall listen and adhere to all lawful instructions given by the deputy throughout the transaction.
- 3. If you choose to transfer firearms to JPSO, follow the procedures below:
 - a. You will be given specific instructions by the responding deputy, prior to the deputy's arrival. You must comply with all lawful instructions prior to and throughout the transfer.

If you possess a Concealed Handgun Permit you must contact the Louisiana State Police so that permit can be suspended.

YOU are required to file the Proof of Transfer Form with the issuing Clerk of Court within ten days of the transfer (exclusive of legal holidays only).

YOU ARE RESPONSIBLE FOR COMPLYING WITH THE CONDITIONS OF THE COURT ORDER WITHIN 48 HOURS.

I. DEFENDANT/LITIGANT/PROHIBITED POSSESSOR

I, _______, do hereby acknowledge that I am prohibited from possessing (PRINT FULL NAME AND DOB OF DEFENDANT/LITIGANT/PROHIBITED POSSESSOR) firearms and/or firearms ammunition pursuant to Louisiana State and Federal laws, including, but not limited to, violations of La. R.S. 14:95.10, 14:95.1, 46:1846 (including Title 46, et seq.), 14:79, and potentially any violation against a family member, household member, or dating partner as defined in 14:35.3, 14:34.9 and Title 46. A violation of La. R.S. 14:95.10 is punishable by a term of one to twenty years in prison and a fine of \$1,000 to \$5,000. In addition to the State law prohibitions, under Federal law the Defendant/Litigant/Prohibited Possessor is prohibited from possessing firearms and ammunition pursuant to the United States Code Title 18, Section 922. A violation of Federal law (18 USC 922(g)(8)&(9)) is punishable by a term of five to ten years in prison, and a fine of not more than \$250,000.
